Legislation Unanimously Approved at the 11/18/14 Council Meeting

Ordinance No. 2014-13 mandates that annual estimated taxes of \$400 or more are paid quarterly throughout the current year.

Important Tax Information

As reported in the October *Walton Hills Journal*, more emphasis will be placed on the "Declaration of Estimated Tax for 2015" when filing your 2014 tax return next year. On November 18, 2014, Village Council approved legislation requiring individuals to pay quarterly estimates only if a taxpayer expects to owe \$400 or more for the 2015 tax year. Prior to this recent law change, the Village required taxpayers to pay quarterly estimates if they expected to owe \$50 or more.

As of November 18th, **Section 890.07** of the Village's codified ordinances which addresses estimated taxes reads as follows:

*Every person shall file a declaration setting forth taxable income, including distributive shares of net profits of unincorporated business entities, estimated to be earned by the taxpayer during the current tax year, together with the estimated tax due thereon, less the tax withheld within the Village and less the tax credit allowed in Section 890.13, unless the entire taxable income is subject to withholding within the Village. If the estimated tax for the current year, less the tax to be withheld and less such tax credit, is less than **four hundred dollars (\$400.00)**, no declaration or payment of estimated tax is required.*

The declaration required by this section shall be filed on or before April 15 of each year during the effective period set forth in Section 890.04 or on or before the fifteenth day of the fourth month of the date the taxpayer becomes subject to tax for the first time.

The "Declaration of Estimated Tax for 2015" located on the bottom third of the 2014 tax return should be filled out in order to determine if a tax liability of \$400 or more will be incurred for the upcoming year. If the outcome of the "Declaration" is \$400 or more, one fourth of the calculated 2015 estimate amount will be due with the 2014 tax return. Therefore, taxpayers will settle up on the remaining tax due for 2014 plus their first quarter estimated payment for 2015. The remaining three quarters will be invoiced by the Village as follows:

- 2nd quarter - Bills sent out in early July —
Due date July 31, 2015
- 3rd quarter - Bills sent out in early October —
Due date October 31, 2015
- 4th quarter - Bills sent out in mid December —
Due date January 31, 2016

Individuals who expect to owe \$400 or less are not required to pay estimated taxes, but **may** choose to do so if they want. Nevertheless, everyone should fill out the "Declaration" to determine whether or not estimated tax payments are required.

As an example: Bob works in Cleveland and earns \$50,000 annually. This is his only income. He had \$1,000 of local tax withheld and remitted to the City of Cleveland. He filed his 2014 Walton Hills' tax return on April 1, 2015 and owes the Village \$250. He also declares on the same tax return that he will earn the same amount for 2015 and expects to owe \$250 for the 2015 tax year. Because Bob's 2015 estimated tax liability is less than \$400, Bob is **not** required to pay estimated taxes.

If Bob's 2015 estimated income is \$100,000 and he expects to owe \$500, Bob must pay an additional \$125 (1/4 of \$500) with his 2014 tax return representing the first of four estimated payments for tax year 2015 (see computation below). Bob will subsequently receive three separate billings from the Village's Tax Department of \$125 each due July 31, October 31 and January 31. When Bob files his 2015 tax return in April of 2016, he most likely will not owe the Village any tax for 2015 if he paid all four of his estimates and his estimate of his income was correct.

Lines 21 through 27 of the 2014 tax return provides the calculation of whether estimated taxes are due. If line 24 is \$400 or more, estimated taxes are mandatory.

21. Estimated taxable income	\$100,000
22. Estimated taxes due	2,500
23. Estimated taxes withheld	<u>2,000</u>
24. Estimated taxes not withheld	\$500
25. First quarter estimated taxes due	125
26. Amount of 2014 refund applied	<u>0</u>
27. Net amount due for 1st quarter	\$125

Line 28 should be used for any prior year taxes owed. The amount on **Line 29** should be the full payment of the tax return which includes the amount owed for 2014, penalty and interest and the first quarter estimate for 2015.

A more efficient alternative for Bob is to ask his employer to withhold the Walton Hills percentage portion with every pay (this is known as "courtesy withholding") and have his employer remit the withheld income tax to the Village of Walton Hills. This would eliminate quarterly estimated payments. Ever since the Village increased its tax rate, more and more employers outside of the Village are remitting payroll tax to the Village as a courtesy withholding for Village residents working outside of Walton Hills.

Please note that in order to **avoid future penalties and interest**, the "Declaration" needs to be filled out on your 2014 tax return and estimated taxes must be paid by the quarterly due date only if you expect to owe \$400 or more for the 2015 tax year.

Economic Development Committee Update

For those of you who have not attended our regular C.O.W. and Council meetings, I would like to review major business highlights as they are being conveyed to the Administration. As we continue to grow our business base and generate new revenue upgrades to our Village, we look forward to 2015 as not only a year of business transition but as a year of solid net growth.

- **Intigral Inc.** The anticipated number of jobs to be added at Intigral Inc. in 2015/2016 is a substantial amount. We have been working closely with Intigral Inc. supporting their rapid expansion. Intigral Inc. has purchased the Ford Union Hall and begun the process of expansion for 2015/16. The Intigral Inc. core business is manufacturing insulating glass units (IGU) and monolithic glass products to window and door manufacturers.
- **Smith and Oby Inc.** Smith and Oby is one of the most respected mechanical contractors in the State of Ohio. Incorporated in 1898, Smith and Oby has a plan to add additional jobs in Walton Hills and building expansion options are in place for 2015.

- **Walton Plastics Inc.** Walton Plastics, a premier plastic and polyurethane extruder in the U.S., has begun the process of expanding their base businesses and adding about 40,000 square feet. They have projected adding additional employment capacity and hiring approximately 40 more employees.

- **Hogan Trucking Inc.** has started the process of expanding their building by another 10,000 square feet and will be hiring in 2015.

Lastly, Council and the Administration have been negotiating the 2015 budget during C.O.W. meetings in November and will continue in December. They anticipate passing a fair budget for 2015 sometime in December. It will be a big challenge for us this year but as you can see, several of our local companies are growing and doing very well. We are anticipating a very good 2015 for our local companies.

My Experience as an Honor Flight Guardian

It was May 21, 2014, I looked at my watch, the time was 5am, and I was driving to Cleveland Hopkins Airport to be a guardian for a day to a WWII veteran who would be flying to Washington D.C. to visit the war memorials. I parked my car and walked in to baggage area #2 and saw dozens of men sitting in wheel chairs eating doughnuts and drinking coffee. Some were laughing and some were somber. There were other people scurrying around helping individuals sign in and get their name tags and introduce guardian and veteran to each other for the first time.

My veterans name was Harold Smith; he was 89 years young and had served in the South Pacific for 3 years. He lives in Beachwood with his wife of 66 years. I say 89 years young because he should have been pushing me in the wheel chair instead of the other way around! I was the lucky one in more ways then one.

A drill sergeant from the Vietnam War kept barking out orders to us guardians, "get those wheel chairs lined up, and make a row here, let's move!" I felt like I had just joined the army that day. He was wonderful, bark he did, but everything went like clock work. And move we did; we fell into formation, boarded a Southwest airplane, and off we went flying into the wild blue yonder to Baltimore where a motor coach would be waiting to pick up 50 veterans, 50 guardians and 15 ground crew.

We landed in Baltimore; the guardians exited the plane and lined up along the sides of the jet way. Wheel chairs were brought in on the side of the plane and as a veteran exited the plane, he was seated in the wheel chair and preceded through the jet way and into the airport.

As I was pushing my veteran through the jet way, I heard this roar. I could not distinguish what the sound was, and I had never heard that sound before. When my veteran and I reached the entrance to the airport, I could not believe my ears or my eyes. The roar was the sound of people, hundreds of people, clapping, cheering, waving, crying, saluting and waving flags as we moved through the airport double file and double time thanks to sergeant you know who. There were television crews interviewing the veterans. Passengers and shop keepers stopped what they were doing to talk with the veterans, telling them their own personal stories. It was surreal!

I will never ever forget that moment! America was on its feet that day! Honoring those men and women who fought so hard so we could have the freedoms we cherish today. And yes, I was one of those crying as I pushed Harold through the airport as men, women and children in the crowd shook his hand and thanked him for his service. I gained my composure thinking this poor guy made it back alive after three years in the South Pacific and now I am going to drown him in the airport with my tears.

We boarded the waiting coaches and off we went to a buffet lunch. Everyone greeted us in the restaurant, we all ate hardily, no K-rations for these guys. From there we visited the WWII memorial; as we walked Harold told me about his war experience in the South Pacific and about how life is now. We moved on to the Tomb of the Unknown Soldier and the changing of the guard. There was complete silence; the only sound you could hear was the cleats hitting the ground as the soldier took his steps, then as he made his turn you only heard the click of his heels. But as the relief soldier came around the corner to relieve the guard, he made one little scuff of his cleat. A fellow guardian said to me "That is to show respect to those veterans here before them today". That is when my friend, my hero Harold shed his tears!

It started raining cats and dogs so we were not able to see some of the others memorials. And we were running late so we had to get back to the airport to catch our plane home. It was now 9pm. The plane was quiet; we all had a lot to think about, some old memories and hopefully some new memories were made today. I felt like we had become a family in such a very short amount of time. There was much appreciation from all the veterans to the guardians and the ground crew who helped makes this Honor Flight a reality for these courageous men and women. It was their day; they waited 70 years to see this day come to fruition.

I have experienced a lot of things in my life, but being a guardian on the Honor Flight was one of the most rewarding things I have ever been involved with. To the men and women of Honor Flight who volunteer their time, there are no words to express the gratitude and respect I have for the way they show their love to these veterans. For eight years these men and women of Honor Flight have made it possible for over 2,000 veterans to be flown free to Washington, D.C. to visit the memorial that was dedicated in their honor.

Christian Children's Home of Ohio ~ Welcome to the Community! ~



The Christian Children's Home of Ohio (CCHO) has brought healing to hurting children and families in Jesus' name in central and northeast Ohio for 45 years. This dedicated organization was founded by concerned and caring individuals affiliated with the independent Christian Churches/Church of Christ movement who wanted to bring Christ to bear on at-risk children and dysfunctional families. Their main campus is located in Wooster, and they have 13 satellite offices. As of October 15th, one of those offices can now be found in our Village. They are located in the basement of the Walton Hills Church of Christ (WHCC) at 7166 Dunham Road. They used to be located on Lee Road in Maple Heights, but that facility was not large enough to support their services. For the past several years, the CCHO has had a longtime relationship with the WHCC, where they conducted all of their training due to the lack of space at their facility. This longtime relationship has led to a permanent home at the WHCC. According to Valerie Turner-Harris, Director of Foster Care and Adoption, CCHO is striving to be a part of the community, to provide well rounded services with Christian values; to help everyone in need and not turn anyone away, and offer services that will make a difference in the community.

The professional programs and services offered by the CCHO include:

- Children's Residential Center (located on their 165-acre Wooster campus)
- New Beginnings Christian Counseling
- Foster Care and Adoption
- City Hill home-based services
- Poplar Ridge Stables and Adventures
- Worship and Retreat Center
- Esperanza de Ana (Hannah's Hope) in Chilca, Peru

Foster care and adoption are the services currently offered at the Walton Hills location. They will also be offering New Beginnings Christian Counseling starting in January, and are currently in the process of hiring a therapist. Below is a brief description of the programs that are/will be offered in Walton Hills:

Foster Care and Adoption: Children in need of foster care and adoption are in a time of transition; their families are unwilling or unable to care for them. These children are a diverse group of African-American, multi-ethnic and Caucasian children of all ages. Some have disabilities and special needs. Many children have

brothers and sisters that need to be placed together. Throughout both of these processes, the CCHO professional staff provides care and education to meet the emotional, spiritual, developmental and physical needs of children and their families from a Christian perspective.

Regarding foster care, the CCHO licenses and places children with individuals or couples married for at least one year through family foster care, therapeutic foster care, medically-fragile care and respite care. **Foster parents must be 21 years or older at the time of licensure.** Assessments are performed, including home studies, criminal background checks, employment and residential history, references, tax records and medical examinations.

Adoptive parents must be 18 or older, can be single or married for at least one year. The services of the CCHO include:

- State subsidized adoption
- Foster-to-adopt program
- Private infant adoption
- Interstate adoption assistance
- International adoption home studies
- Assessment, including home studies
- Pre-service and ongoing training
- Child and family matching
- Placement and finalization support
- Child, parent and family counseling
- Respite care
- Adoptive support group



New Beginnings Christian Counseling: Professional, Christ-centered counseling to children, adults, couples and families for an array of issues including marriage counseling, family and child counseling, and counseling for grief, depression, addictions and disorders. CCHO therapists bring a faith-based perspective to treatment, but it is not necessary for patients to hold a Christian belief system to attend therapy.

The CCHO is well on its way to realizing their vision of being the organization of choice in Ohio for providing services that transform lives, families and communities. For more information on the services offered at the CCHO, please call 216.475.9336



Spotlight on

Carol Weitzman

One of the many threads in the fabric of our Village

Resident Carol Weitzman enjoys her peaceful life in Walton Hills. She was born in Bedford Hospital, grew up in Macedonia, and graduated from Nordonia High School. Afterwards, she attended and graduated from computer school. Although she never worked in the field, she was qualified to be a computer programmer. She worked as a stock maintenance clerk at Western Electric, as the head teller at National City Bank in Bedford, and is currently employed at Wal-Mart in Bainbridge.

Carol met her husband Jerry at Nordonia High School – and they became high school sweethearts. They were married in 1969. Jerry served in the United States Army and was sent to Panama, the southernmost country of Central America and the whole of North America. Carol joined her husband and lived in Panama City for 18 months. When Jerry's service was over in 1971, he and Carol drove home for what she calls the "trip of a lifetime." It took over two weeks, but they had a great time and did a lot of sightseeing along the way.

Carol and Jerry moved into their home on Conelly Boulevard in 1984. They

have a daughter Kimberly and two sons – Nathan and Donny. They also have one granddaughter. Carol was a stay-at-home mom, which was very important to her values. In 1996, she was reading about the search for 75 "Betty Crockers."
